

Public Sector Goes Circular

[Circular Economy] On 25 January, our Secretary-General participated in the Conference on the new business models and the role of public sector in the transition to a Circular Economy in Europe. The conference showed how business models, technologies and capabilities influence the shift. High-level representatives from government, business and associations debated how EU-level policy becomes local policy, which then interacts with private interests. Vanya Veras presented Municipal Waste Europe structure, its role and scope of action, the main reforms under the new European Commission Circular Economy package and its prospective effects on the sustainable municipal waste management carried out by local authorities and regions across Europe. Vanya called for a joint approach for resource efficiency and energy policies at EU level, namely that the Circular Economy and the Energy Union go hand in hand. Moreover, Ms Veras pointed out the need for clear rules and transparency for the Extended Producer Responsibility Schemes and underlined that the separate collection of municipal waste can help valuable resources find their way back to the economy, stimulating Europe towards a true Circular Economy.

Municipal Sector potential of South-East Europe

[Municipal Infrastructure Investments] On 27 January, our Secretary-General participated in the Communal/Municipal Infrastructure Conference on the investment projects and financing from EU funds in South-East Europe (SEE). The conference brought together leading municipal utility companies from the SEE region, Croatian and Slovenian Members of the European Parliament, and important sectoral associations from Brussels. Vanya Veras presented Municipal Waste Europe structure, its role and scope of action, the main reforms under the new European Commission Circular Economy package and its prospective effects on the sustainable municipal waste management carried out by local authorities and regions across Europe. She also put emphasis on the need for the EU to channel investments and funding on fine-tuned waste management projects that contribute to achieving the objectives of a true Circular Economy, in particular at the local and regional level.



Circular Economy: The European Economic and Social Committee (EESC) will elaborate an opinion report addressing the whole new Circular Economy package under the responsibility of its rapporteur, Cillian Lohan, Chief Executive Officer (CEO) of the Irish Natural Forestry Foundation. In order to ensure his opinion closely reflects the views of the European civil society, on 28 January the Committee will organise a public hearing to gather input from interested stakeholders and experts at an early stage. The Agriculture, Rural Development and Environment section (NAT) Study Group will work on this dossier and the final adoption of the Committee Opinion Report is foreseen for the Plenary session of 27-28 April. The Committee of the Regions has appointed Domenico Gambacorta rapporteur for the package, and is expected to adopt its opinion on the legislative proposals on waste in June 2016, whereas the deadline for National Parliaments to submit comments on the proposals is 2 February 2016. On 22 January, the European Parliament Research Service published a Economy briefing citing, among others, Municipal Waste Europe preliminary views as expressed in its press release on December 2, and an additional briefing in which it makes a comparison of the main provisions between the previously withdrawn and the new Circular Economy package.

Hazardous Waste: EU governments should incorporate hazardous waste into their waste prevention programmes, according to a <u>study</u> for the European Commission. The amount of hazardous waste generated per capita has remained more or less stable in recent years and the prevention of hazardous waste "does not seem to be on the political agenda for most member states", Bipro Consultancy said in the study finalised in December. Hazardous waste should be included in targets and indicators in waste prevention programmes, the consultants said. In general, there are no major gaps in the transposition of EU requirements on hazardous waste into national legislation but implementation is different across the EU, the consultants found.

Food Waste: On 22 January, we secured a meeting with Mr Ossi Martikainen (Group of the Alliance for Liberals and Democrats in Europe), the Finnish rapporteur on Food waste in the Committee of the Regions. We discussed food waste and loss in Europe under the European Commission new Circular Economy package and Vanya Veras gave the rapporteur an inclusive description of the relevant food waste prevention practices across the EU Member States. Since the rapporteur was interested in food waste prevention in the EU, we will provide him with relevant data on food waste at EU level from key publications and reports. Mr Martikainen will have his report finalised by February 5 and, before tabling it for the final adoption by the Committee, he will share it with us for expressing our comments and proposing any amendments.
